LCA Transfer Process

Limestone University Closure Impact

- Limestone University has ended its role as an SC Institution of Higher Education
- Triggers closure of Limestone Charter Association (LCA) per state law
- Not a reflection of LCA performance or leadership
- This year is our Transition Year 25-26 and LCA is working with the State Department of Education through the closure protocol
- LCA continues LEA and authorizer responsibilities
- No new schools approved, or transfers accepted into LCA
- o All LCA sponsored schools must transfer to new authorizers by July 1, 2026
- Next Steps for Schools
 - o Engage in internal decision-making and community consultation
 - o Identify viable authorizers and initiate discussions
 - o Submit formal selection through board resolution to LCA by December 15, 2025
 - o Prepare for transition completion by July 1, 2026
- o Final Notes from SCDE
 - Closure not a reflection on LCA performance
 - o Process aims for orderly, student-centered transition
 - LCA and SCDE will remain in close communication
 - New Authorizers that register with SCDE will also be eligible to receive schools
